Subject: All Plan Letter APL 22-031

Attention Provider Partners,

This communication is to inform you of the newly enacted California state legislation covered in All Plan Letter APL 22-031.

We have identified and highlighted the following legislation that has a higher impact:

SB 1473: Healthcare Coverage

 Out-of-network (OON) providers are prohibited from; balance billing members for COVID diagnostic or screening testing and reporting adverse information to a consumer credit reporting agency or commencement of civil action. The Plan is not required to cover OON COVID health care services related to testing.

SB 225: Timely Access to Care

• Effective January 1, 2023, the Plan is required to incorporate timely access standards into its quality assurance systems. Allows DMHC to take disciplinary action including assessment of administrative penalties for any noncompliance with any provisions.

SB 1207: Maternal and Pandemic-Related Mental Health Conditions

• Effective July 1, 2023, the Plan is required to develop a maternal mental health program designed to promote quality and cost-effective outcomes, including quality measures to encourage screening, diagnosis, treatment, and referral. Includes coverage for doulas, incentive training opportunities for contracted obstetricians, and education for enrollees in the program.

SB 245: Abortion Services

• Effective January 1, 2023, this bill prevents the collection of any cost-sharing including copays for any abortion or abortion-related services, for non-high deductible health plans. Prohibits any utilization management, prior authorization, or annual or lifetime limits for abortion services.

SB 523: Contraceptive Equity Act of 2022

• Effective January 1, 2024, the Plan must provide coverage for the following services and contraceptive methods for members. A prescription is not required to trigger coverage. Point-of-sale coverage must be provided at in-network pharmacies without cost-sharing or medical management restrictions. The Plan shall not impose restrictions or delays on vasectomy services and procedures.

SB 923: Gender-Affirming Care

• Within 6 months after the Department issues guidance and no later than March 1, 2025. Providers and office staff must complete evidence-based cultural competency training for the purpose of providing trans-inclusive health care for individuals who identify as transgender, gender diverse, or intersex (TGI). The plan provider directory must include information identifying which in-network providers offer: Gender-affirming services.

AB 2581: Mental Health and Substance Use Disorder Providers

• Effective January 1, 2023, this bill establishes new requirements for credentialing mental health and substance use disorders providers. Provider qualifications must be verified and assessed within 60 days of receiving a completed credentialing application. Upon receipt of an application, applicants should be notified within seven business days that the application is complete.
